1. Course Objectives and Attainment:

The course is taught online by the course convenor, Mr Chan Leng Sun, SC, and other visiting lecturers from the Singapore International Arbitration Centre (SIAC), Young SIAC (YSIAC) Committee Members, and other leading international arbitration practitioners and arbitrators. Professor Makoto Shimada and Professor Masako Miyatake serve to administer the course and conduct assessmenton site.

Arbitral institutions are important stakeholders in the field of international arbitration, but the nature and importance of their role have often been overlooked. The course seeks to introduce participants to the role and function of arbitral institutions in the practice of international arbitration, and to the complex issues that arbitral institutions face in the administration of arbitrations, including, amongst others, appointment of arbitrators, issuance of arbitral rules and practice notes, and guiding and shaping the development of international arbitration.

2. Relationship to the relevant course:

International Commercial Arbitration I, II, Arbitration (Practical Training course) and Introduction to Arbitration. SIAC and Institutional Arbitration II is the same course as SIAC and Institutional Arbitration I except that a final research paper is assigned to the students of II as the basis of assessment.

1. Course Objectives and Attainment:

The course is taught online by the course convenor, Mr Chan Leng Sun, SC, and other visiting lecturers from the Singapore International Arbitration Centre (SIAC), Young SIAC (YSIAC) Committee Members, and other leading international arbitration practitioners and arbitrators. Professor Makoto Shimada and Professor Masako Miyatake serve to administer the course and conduct assessmenton site ("KLS Professors").

Arbitral institutions are important stakeholders in the field of international arbitration, but the nature and importance of their role have often been overlooked. The course seeks to introduce participants to the role and function of arbitral institutions in the practice of international arbitration, and to the complex issues that arbitral institutions face in the administration of arbitrations, including, amongst others, appointment of arbitrators, issuance of arbitral rules and practice notes, and guiding and shaping the development of international arbitration.

International Commercial Arbitration I, II, Arbitration (Practical Training course) and Introduction to Arbitration. SIAC and Institutional Arbitration II is the same course as SIAC and Institutional Arbitration I except that a final research paper is assigned to the students of II as the basis of assessment.
